

TERMS AND CONDITIONS: MASTERCLASS FORESIGHT-DRIVEN INNOVATION 2020

1 Registration and payment terms

- 1.1 By filling out and sending the contact form on fdimasterclass.com, the participant makes a request for participation in the masterclass on the indicated date. A preliminary reservation is confirmed by Rohrbeck Heger by email.
- 1.2 To secure the spot, the participant needs to make an advance payment of 30% of the program fee within 14 (fourteen) days of receiving the invoice. If the advance payment remains unpaid after this period, Rohrbeck Heger reserves the right to assign the spot in the masterclass to another participant.
- 1.3 The remaining amount (remaining 70% of the program fee) is due 10 (ten) days prior to the first day of the masterclass. If the total amount remains unpaid until the first day of the masterclass, Rohrbeck Heger reserves the right to refuse participation.

2 Cancellation and no-show

- 2.1 In order to successfully run the masterclass, a minimum registration of 12 participants is required. Rohrbeck Heger reserves the right to cancel the program in the case of insufficient registrations. In this case, the advance payments will be fully reimbursed.
- 2.2 If a participant has to cancel the registration for any reasons until 10 days before the first day of the masterclass the remaining amount will not be charged. The advance payment will not be reimbursed.

3 Generation of content by participants ("participant-generated content")

- 3.1 In the course of the masterclass, participants will create content, such as scenario descriptions, business ideas and visualisations, hereinafter referred to as "participant-generated content".
- 3.2 The participant grants Rohrbeck Heger GmbH the free, non-exclusive right to use the content in all known forms of use, including duplication, processing, publication and public accessibility, translation, processing, dissemination, and in particular, the right to publish the content on the Rohrbeck Heger websites or websites run by third parties. Rohrbeck Heger is granted the right to allow users of these websites unrestricted access to this content, to transmit content, make it available and accessible online and in proprietary online services. Rohrbeck Heger also reserves the right to disseminate this content on all known data carriers free-of-charge or with payment of compensation, as well as the right to use content in advertising materials produced by Rohrbeck Heger or on behalf of Rohrbeck Heger.

4 Copyright and Intellectual Property

- 4.1 Copyright and other intellectual property rights in all deliverables, including but not limited to drawings, reports, calculations, specifications, software models and other documents prepared by Rohrbeck Heger in connection with the program, remain vested in Rohrbeck Heger. Subject to payment of all fees due, the participant shall have a royalty free license to use the deliverables for any purpose connected with or intended by the scope of the project. Nothing herein shall prevent or limit Rohrbeck Heger's right to include photographic or artistic representations of the project among its promotional and educational materials including without limitation, as part of Rohrbeck Heger's website or elsewhere.

5 Liability Limit

- 5.1 We will use reasonable skill, care and diligence in the performance of the services and will be liable only to the extent that we have breached this obligation. Our liability shall be limited in aggregate to the total compensation received by the contractors provided that such limitation is not prohibited by law.

6 Miscellaneous

- 6.1 These Terms and Conditions and the relationship between the participant and Rohrbeck Heger shall solely be governed by German law.
- 6.2 Should one or more provisions of these Terms and Conditions be or become invalid, the validity of the remaining provisions shall not be affected.
- 6.3 Rohrbeck Heger reserves the right to amend these Terms and Conditions at any time with effect for the future.
